Executive Director's Message



It is my pleasure to present my Annual Report for the Manitoba College of Family Physicians for the fiscal year 2022. This report highlights the key achievements, financial results and events that took place during the year.

In review of our audited financials, you will see that again, we have ended the year in a surplus. This year, we have been able to bring in a substantial amount of new revenue, more than in the college's history. Our membership numbers remain strong, serving over 1600 members.

Capacity building remained a focus. We continued to mentor students through Indigenous Professional Association of Canada (IPAC). MCFP utilized interns for much of its administrative help, allowing the organization to save on costs, mentor Indigenous youth and align with several of the Truth and Reconciliation Commission's calls to action by providing continued employment.

We applied for a grant to support our CPD (Continuing Professional Development), and with that grant, we were able to purchase technology for our board room. This grant assisted with staffing, training and the IT supports to facilitate Practice Incentives Essentials (PIE) or all of Canada. For the first time in the MCFP history, we will provide paid employment for Family Physicians. We signed a new agreement with National to lead this superior program. All operational processes are in place, we have been awarded accreditation, communicated to all family medicine programs and regulators across Canada and we have been recruiting Family Physicians for the program.

We reached out to every member of the Legislative Assembly in Manitoba regarding Family Doctor Day, our Mayor, all MOH, all RHA's and other dignitaries to remind them of this important day. We arranged media spots for Family Doctor Day, visited Winnipeg clinics with Family Doctor Day celebration gift packs and sent gifts to Family Physician clinics across Manitoba. The Minister of Health released a statement, and we received a proclamation from our request.

We hosted Canadian Association of Physicians for the Environment (CAPE), supported a member interest group on addictions, assisted members with accrediting continuing professional development, met with members to design initiatives with primary care mapping and funded initiatives to take the burdens off their practices. We attended Family Medicine undergrad meetings and met with the IMG Director at the University of Manitoba to understand directly from international grads, what their needs are. We sponsored the residents retreat, and we continue to work closely with our Family Medicine Interest Group (FMIG). We advocated for BASE E-Consult and transformed the MCFP office yet again into a TV studio for the 64th ASA.

Overall, the Manitoba College of Family Physicians has made significant progress in its mission to promote excellence in family medicine through education, advocacy and research. We are grateful to our members, partners and stakeholders for their ongoing support, and we look forward to another successful year in 2023.



Primary & Community Care (PACC) Mapping is an engagement and planning approach developed by the Innovation Support Unit at The University of British Columbia and facilitated right here in Manitoba. PACC Mapping helps communities explore how they could address local primary care needs and service gaps. Employing a person-centred approach, those who are actively involved in planning primary care transformation work together to co-create tailored, local solutions in a facilitated workshop.



The MCFP is collaborating with the Canadian Primary Care Sentinel Surveillance Network (CPCSSN) to recruit primary care providers who agree to have their electronic medical records (EMRs) (de-identified) data extracted.

The aim of this project is to establish a de-identified data repository that will support primary care providers in conducting quality improvement, research on primary care delivery and impact, and disease surveillance of common conditions.

The MCFP is assisting CPCSSN in this project to enhance the capacity of primary care settings in conducting these activities.







Family Physician of the Year

Throughout his 32-year career as a Family Physician in Manitoba, Dr. Thiessen developed and used his leadership skills as a chief of staff at Bethesda Hospital, chief medical officer at Southeastern RHA, and, prior to amalgamation and after regional health amalgamation, as the chief medical officer of Interlake – Eastern RHA. Dr. Thiessen led the IERHA's Medical Services Department for almost a decade prior to his retirement at the end of 2021.



He worked hard to strengthen the voice of family physicians throughout the region and spearheaded the formation of first Regional Family Medicine Specialty Lead. Dr. Thiessen is known for his calm demeanor, integrity, loyalty, consistency and bridge building capacity. His compassionate leadership style has helped many physicians make IERHA their home and brought the community of IERHA physicians to work together collaboratively.

Awards 2022

Awards of Excellence

Dr. Lisa Monkman has committed her professional career to improving the quality of care for rural Manitobans and the Indigenous community with her career in Family Medicine, teaching, community care and service to the structurally disadvantaged. Her role in promoting traditional healing practices within a family medicine context is award worthy. Presently, she serves the Brokenhead Ojibway First Nation and surrounding area providing primary care, family medicine services and opioid agonist therapy.



Dr. Monkman's leadership in the post graduate medical education office in Indigenous health combined with her mentorship of learners is an example of her groundbreaking work in family medicine. She couples this with an active clinical practice supporting care to the community of Brokenhead, using continuity of care with a trauma informed approach to improving care to the residents of the area. She continues to help her patients with resources such as Jordan's Principle, mental health counselling and transportation to medical appointments. Her leadership work with the College of Physician and Surgeons with Truth and Reconciliation will improve care across the province for Indigenous Manitobans.



Awards of Excellence

Dr. Camisha Mayes is a very dedicated and knowledgeable Family Physician who is committed to the structurally disadvantaged populations that she serves and much of her work is focused on the Downtown/Point Douglas population in Winnipeg. She is committed to incorporating Indigenous ways of knowing and supporting the Truth and Reconciliation recommendations in primary care. She is extremely supportive and sensitive to the rights and care of the Indigenous population as well as all underserved populations in our system.

Dr. Mayes spearheaded a collaboration by bringing family physicians together to discuss the addiction crisis in our communities and work on better ways that we can work together to support each other and our patients by looking at referral pathways, as well as pooling and sharing of resources. Under the leadership and organization of Dr. Mayes, the DT/PD OAT network began meeting almost three years ago in an effort to bring experience and expertise together and tackle shared issues and challenges.

With the onset of the pandemic, Dr. Mayes became heavily involved in ensuring that the needs of the Downtown/Point Douglas population would not be overlooked. Her approach was overarching, recognizing the unique issues that are prevalent in this population-addictions, homelessness and poverty, STBBIs and TB. She has worked incredibly hard at making sure the Thunderbird House Covid Testing and Assessment site has provided "wrap around services" to the population.



Treasurer's Report

Dear Members,

I am pleased to present the Treasurer's Report for the Manitoba College of Family Physicians (MCFP) for the 2022 fiscal year. I am pleased to report that the MCFP's financial position remained strong.

Because of the excellent leadership from our Executive Director, we were able to maintain our financial stability through prudent management of expenses, securing grants and special project funding, decreasing administration costs, and realizing a strong performance in our investment portfolio.

The largest source of annual revenue for the MCFP is membership dues, which is currently set at \$200 for each full member. Our chapter dues has remained the same since 2019. This year, we did not receive the FMF funding, which was estimated to be around \$30,000. Additionally, our Executive Director was able to secure a grant of over \$40,000 to increase our teaching capacity with technology and position us to facilitate the PIE course nationally. She also secured additional funding for special projects to support family physicians in their practices, totaling over \$120,000. This is a first for the College, having revenue outside of what is contributed from national. PIE will also bring new revenue to the College to further support our members in the future.

As of October 31, 2022, the MCFP's net assets totaled \$676,242, increasing by over \$60,000 or 9.2 % during the fiscal year. This result was mainly due to the performance of the investment portfolio, reduced expenses including lower rent, the use of interns and decreased staffing costs (including involving interns in the activities of the College), ASA revenue, special projects, and timing of expenses from special projects.

Despite the pandemic, a lower attendance at our ASA, no FMF surplus revenue and an environment where many Provincial Colleges are experiencing financial difficulties, we remain in a strong financial position. The Board and Executive Director have managed the College in a prudent manner, resulting in a positive cash position at the end of the financial year of \$379,024, which is up 14% from the last fiscal year.

In the 2022 fiscal year, our operating expenses totaled \$388,202, leaving us with an excess of revenue over expenses of \$62,293.

The MCFP's complete audited financial statements, related notes, and the auditors' reports thereon can be found in your member message titled "Annual Meeting Package". Heartland, our external auditors, issued an unmodified opinion on the fiscal year 2022 financial statements and did not identify any material weaknesses, significant deficiencies, or areas of noncompliance with laws and regulations.


