Meeting called to order at 1:20pm NBCFP President, Dr. Darren Martin, welcomed all in attendance

1.0 – Approval of Minutes from 2018 Annual Meeting

Motion to accept the 2018 AMM Minutes was duly moved and seconded. CARRIED

2.0 - NBCFP President's Report

Dr. Darren Martin met with Premier Blaine Higgs and with Liberal party as well. Main discussions were to advocate for increased availability of psychology services in New Brunswick. Also, working to strengthen NBCFP relationship with NBMS, whereas NBCFP wants to be at the table for family medicine discussions and decisions. Focus on increasing positive recognition of family physicians and demonstrate interest in partnerships for upcoming projects. NBCFP, in wanting to increase communication with members, has created the Key Messages, which are a few important messages coming from each of the Board Meetings and are posted on NBCFP website for members.

In wanting to increase robustness of governance, a new Board of Directors composition pilot project has been developed, creating a few new policies and terms of reference.

First Five Years of Family Practice: Work on creating useful content to help in the transition from Resident to practicing Physician.

For Health & Wellness: NBCFP is excited to have allocated a \$2,000 to fund projects that will benefit the health of the patients in New Brunswick.

One thing to be proud of for Family Physicians in NB is that we are the best province in Canada with 93.6% of the population having a primary care provider.

The objective for the next year is to emphasize on action and effectiveness of our Board, to engage and provide value to our membership and help meet the needs of our communities in advancing family medicine and improving the health of the population.

3.0 CFPC President's Report

Dr. Paul Sawchuk introduced himself as a Family Physician from Manitoba and indicated that he was enjoying his visit to New Brunswick, also indicating that 94% of population having a family physician is a very impressive figure. NB is a very pro-Family Doc environment and the involvement of Family Physicians in Hospitals in NB is great. Family Doctor patients' outcome is best. Attended Board meeting yesterday, Family Medicine is doing well in New Brunswick. Looking at future, long term positions. As for virtual care/artificial intelligence, CFPC is looking into impact of risks in artificial intelligence.


4.0 - CFPC's CEO report
