President's Report



Dr. Joanna Lynch
President

As we surpass the second anniversary of the global pandemic, I would like to acknowledge the invaluable contributions you, as Family Physicians, make every day to the lives of your patients. Manitoba's family doctors responded to the challenges posed by Covid-19 by flexing our generalist muscles and leveraging the trust our patients have in us. Whether by taking on new hospital roles, becoming involved in local efforts to vaccinate, or offering virtual visits to provide continuity of care, Family Doctors enabled the system to adapt to the rapidly changing imperatives the virus presented us with.

While many of us are exhausted and disheartened, it is important to reflect on the fact that the actions we have collectively taken have made a huge difference, reducing loss of life and mitigating the impact of the pandemic on the health care system.

The pivotal role of Family Physicians in the system brings a unique perspective. We can anticipate the long-term effects that the pandemic will have on our patients, our communities, and ourselves. We see first-hand the toll it has taken on the mental health of Manitobans, the disproportionate effect it has had on the most vulnerable in our communities, the backlogs it has created and the effect that has on the care we provide. As your professional medical home, the Manitoba College of Family Physicians (MCFP) aims to help you elevate the issues that are concerning you, and advocate for change where needed, through active stakeholder engagement. We are also here to support you in your practice, by providing the continuing professional development because you need to continue to provide the highest quality care to your patients. We are committed to promoting and protecting the vital role that Family Physicians play in the system, for the benefit of all Manitobans.

Over the past year, the MCFP has been active in keeping Family Doctors at the center of the effort to manage the pandemic. The organization was a key partner in early education efforts and the push to include Family Physicians' offices in the vaccine rollout. We worked with national partners and local family physicians to develop a Covid-19 toolkit containing resources with local content. A highly successful partnership with University of British Columbia (UBC) resulted in immPACC, an initiative which was designed to help primary care clinics develop local strategies to reach out to the under- and un-vaccinated in their area. This project has been extended, and will now shift to assist clinics in addressing the unmet primary care needs resulting from delays in accessing care.

President's Report

The College has taken on an increasing role in continuing professional development. We have assumed the role of delivering certified Quality Improvement education on behalf of the CFPC across Canada. This training will help Family Physicians develop the necessary skills to continuously improve care delivery using their own data, and help them meet the requirements of provincial regulatory bodies for ongoing QI in their practices.

The second virtual ASA, held in April 2021, was highly successful and allowed rural and remote Family Physicians to participate in large numbers. The success of the virtual format has led to improved expertise in delivering high quality CPD to a larger audience. As we look forward to the 2023 conference, where we can again meet many of our colleagues in person, a virtual option will continue, in order to meet the needs of all of our members.

The MCFP is active in promoting the role of Family Physicians and the values of family medicine with stakeholders, including the provincial government and Shared Health. We work closely with our national organization on issues in common across Canada, such as advocacy for the post-pandemic continuation of virtual care that demands continuity of care at its core (see CFPC document "Access Done Right"). While much of this work occurs behind the scenes, we are also active in the public sphere, reaching out on social media and traditional media to support your work in the public forum. One example is the collaboration to endorse the "PaRx" program, an effort to encourage patients to get outside for the health and mental health benefits that nature provides (see www.parkprescriptions.ca for more information on how you can prescribe nature and National Park passes to your patients).

As President of the Manitoba College of Family Physicians, I look back with pride on the work that our organization and our colleagues have done in the past year. I would like to extend heartfelt thanks to Past President, Dr. Ian Alexander, whose long tenure as a member of the Board of Directors and Executive of the MCFP is at an end, for his dedication, insight, and immense contributions. I would also like to thank Lisa Goss, whose vast knowledge, energy and compassion are an inspiration. The challenges and rewards of our profession do not end with the pandemic, and I look forward to my final year in this role, to continue the work of supporting Manitoba's Family Physicians as we edge toward a new normal.

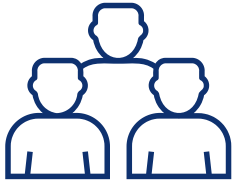

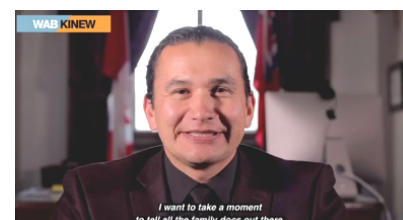
Family Doctor Day 2021

MCFP Special Projects 2021

Data Extraction



The MCFP aids in recruiting practices to allow for their de-identified data to be extracted to support capacity in primary care settings to conduct:

- Quality Improvement by developing reports for providers
- Research on primary care delivery and impact
- Disease Surveillance of common conditions

Practice Improvement Essentials (PIE)

In 2021 the MCFP signed an agreement with the CFPC to take the lead on PIE, a quality improvement course created by Family Physicians for Family Physicians.

Quality Improvement (QI) provides approaches and methods to assist Family Physicians in their commitment to stay at the forefront of providing high quality care, while improving the experience for patients and health care providers alike.

Awards 2021

The 2021 Family Physician of the Year Dr. Christine Buchel



Family Physician of the Year Award

This award is granted annually to recognize an outstanding Manitoba Family Physician who embodies the four principles of family medicine: who is a skilled clinician, community based, a resource to a defined practice population, and whose relationship with the patient is central to their role.

Dr. Christine Buchel is a humble teacher and mentor who has spent the majority of her career working from a harm reduction perspective to provide care and service to Winnipeg's most vulnerable populations. She has brought primary care to youth in school, newcomers, and women who have been exploited. She provided care for the trans/two spirited community, those with addictions or living with chronic conditions like HIV, those that are homeless and those who have experienced traumas such as residential school. Dr. Buchel was instrumental in the intake of almost 1500 new patients at the Aboriginal Health & Wellness.

Dr. Gary Beazley Patients Medical Home Award

The Manitoba College of Family Physicians has created the Dr. Gary Beazley (Patient's Medical Home) Award, recognizing the impact of an outstanding leader of Family Medicine. Dr. Beazley was a renowned Family Physician in Manitoba who, throughout his long career, embodied, exemplified, and championed many aspects of the Patient's Medical Home. He was passionate about teaching, he modeled comprehensiveness and continuity of care and was a powerful and outspoken advocate of inter-professional collaboration. This award is granted annually to the Family Physician or physician practice group that best embodies the principles of the Patient's Medical Home.

Aboriginal Health & Wellness Centre

The staff at the Aboriginal Health and Wellness Centre (AHWC) use a holistic approach to provide primary health care to their constituents. Primary care services are offered following the Medicine Wheel to address the physical, mental, spiritual and emotional wellbeing of the constituents they care for. The team works in collaboration with one another and is comprised of Family Physicians, cultural advisors, community health workers, social support workers, nurses, clinical psychologist, administrative staff and other allied health professionals.



Awards 2021

Award of Excellence

This award was created as a way for both the provincial and national Colleges to recognize Family Physicians who are worthy and recognized through nomination at the provincial chapter level. The Award of Excellence recognizes members who have made outstanding contributions to one or more of the following: patient care, community service, hospital or health care institutions, College activities (national and chapter), and teaching, research, or other elements of the discipline of family medicine.



The Family Medicine Obstetrics Network - Artemis Group

The Family Medicine Obstetrics Network – Artemis Group was created in 2007 by a group of family physicians (Dr. Amanda Condon, Dr. Jacqueline Gougeon, Dr. Ming Munikar, Dr. Katherine Kearns, Dr. Kelby Clerverly, Dr. Chaitasi Intwala, Dr. Sandra Lee, and Dr. Gabrielle Leung) practicing intrapartum obstetrics at St. Boniface Hospital in Winnipeg. A commitment to Family Medicine Obstetrics is core to the group, recognizing the importance of a family and community-oriented option for maternity care. Role modelling and ensuring family medicine residents have exposure to this aspect of family medicine practice is a priority.

Dr. David Willems is a passionate teacher and leader in HIV and addictions treatment in the community, with over 27 years of service to patients living in downtown Winnipeg.

Dr. Willems is known as a respected and sought-after mentor in family medicine. He has worked his entire career providing comprehensive care to very complex patients in community health centers. His nomination highlighted him as an excellent leader and colleague.

I am pleased to provide the Treasurer's Report for the fiscal year ending October 31, 2021. The audited financial statements have been provided to each member and will become available on our new website.

Despite tremendous challenges resulting from the COVID-19 global pandemic, the financial position of the Manitoba College of Family Physicians (MCFP) remained strong throughout the 2020/2021 fiscal year. This has been achieved by prudent fiscal management, and ongoing revenues provided through the delivery of CPD programs.

Following a Request for Proposal (RFP) that was reviewed by the MCFP Board of Directors, and as approved at the 2021 Annual Meeting of Members, the 2020/2021 external audit was conducted by Heartland Chartered Professional Accountants. I am proud to provide their unqualified opinion on the 2020/2021 financial year, which does not identify any significant deficiencies or noncompliance with all appropriate laws and regulations.

As such, the MCFP continued to operate from a strong financial position for the entirety of the financial year. Your Board of Directors and Executive Director have ensured that assets have been maintained and grown, while ensuring that even in challenging times, expenses have not exceeded revenue. This has been accomplished by amortizing our outstanding assets, and strategically reducing expenses, without reducing services to our members.

Your ongoing membership has helped support the operation of the MCFP and has strengthened our organization. This ongoing support helps grow our College and allows us to advocate on behalf of Family Doctors across Manitoba.

It has been a great privilege to serve as your Treasurer for the 2020/2021 fiscal year.
