As Dr. Appel began to wrap up her report, she invited members to share their insights, concerns, and aspirations with the College that will help to guide strategic direction. Finally, Dr. Appel extended thanks for the members' trust and support, excited for the College's future and pledged her commitment to making a positive impact on the organization, community, and profession.

# 6. Executive Director's Report

Lisa opened the Executive Director's report by thanking the MCFP team, board, volunteers, and members. She highlighted strong member engagement — with a 70% message open rate within 24 hours — and encouraged members to connect over the summer as strategic planning continues, emphasizing that *we are listening*. Lisa acknowledged the financial challenges of the past year and noted that moving forward, the College's priority will be maintaining core advocacy and education efforts while ensuring sustainability. She closed by thanking members for their continued trust and support.

Lisa introduced Dr. Ian Alexander to present the slate.

# 8. Installation of the New President

Dr. Alexander welcomed Dr. Appel to the podium along with Dr. Michael Green, President of the CFPC. Dr. Green briefly introduced himself before passing on the symbol of office.

# 9. Awards Announcement

Dr. Appel announced the date and time of the upcoming awards lunch and invited members to attend. She shared that the Board is currently reviewing the awards and their Terms of Reference. The College welcomes members interested in volunteering on the committee, which will focus on vetting nominations and reviewing how awards are granted. Members are encouraged to put their names forward and share their ideas.

## 10. CFPC President's Address

Dr. Appel welcomed Dr. Green back to the podium, where he shared reflections on his early days in family practice and his enthusiasm for the work being done in Manitoba to advance Indigenous health. He congratulated the MCFP on a strong year of advocacy, as highlighted in the Annual Report, and thanked the board and staff for their dedication.

Dr. Green commended the College's role in strengthening family medicine in the province. Nationally, the CFPC continues to advocate for appropriate remuneration models and sustainable alternatives to fee-for-service. He emphasized the CFPC's recent focus on reducing administrative burden, including engagement with MPs, Senators, other medical organizations, and the CRA to streamline processes like patient tax forms.

These efforts aim to free up physician time, improve access to care, and reduce burnout. Dr. Green also noted the success of national awareness campaigns, which reached millions and generated over 1,400 public letters to government leaders. He highlighted progress on the Patient's Medical Home—*My Healthcare Teams* in Manitoba—as a model where family physicians can thrive.

Dr. Green closed by encouraging ongoing promotion of family medicine as a rewarding career, especially to learners and residents, and thanked the MCFP for their hospitality and collaboration in advancing the profession.
